1.4 DELIVERY, STORAGE & HANDLING

- Deliver materials in manufacturer's original, unopened, undamaged containers with identification labels intact. D.

2.2 EXISTING PRODUCTS

- A. Exterior insulation above-grade perimeter
 - Exterra
 - a. Standard: ASTM C578, Type I EPS, CAN ULC/S701, Type 1 EPS
 - b. Thermal Resistance: Minimum R per nominal inch of 5.0 (actual thickness = 1.06") when tested in accordance with ASTM C518 at 75 degrees F. mean temperature.
 - c. Compressive Strength at 1" thickness: Minimum 10 psi when tested to ASTM D1621 (70 kPa under CAN/ ULC S701)
 - d. Water Absorption: Maximum 1.1% (1.1% under CAN/ULC S701)
 - e. Water Vapor Permeance at 1" thickness: >1.0 perms (>57 ng/Pa-s-m²)
 - f. Breathable at up to 2" thick, per ASTM E96
 - g. Water resistive barrier at thickness greater than 9/16", per ASTM E331

2.3 MATERIALS

- Block molded expanded polystyrene (EPS) made of BASF Neopor Plus beads
- Perforated reflective and clear polypropylene laminate. Perforations spaced at ½" on center maximum.

2.4 MANUFACTURED UNITS

- Board size: 4 ft x 8 ft
- Board thickness: 0.5625 in (14 mm), 0.625 in (16 mm), 1.0 in (25 mm), 1.5 in (38mm), 2.0 in (51 mm), or as required.









2.5 ACCESSORIES

A. Adhesives:

- Type recommended by insulation manufacturer for application.
- 2. Gun grade, mastic type, compatible with insulation and substrate.
- 3. Tape: Perma R Sheathing Tape, Blue Tuck Tape, 3M air and vapor barrier flashing membrane, Blueskin permeable flashing tape.
- 4. Insulation fasteners: Impaling clip of (unfinished, galvanized steel, plastic or nylon) with washer retainer (and clips) to be (adhered) (mechanically fastened) to surface to receive board insulation, length to suit insulation thickness and substrate, capable of securely and rigidly fastening insulation in place.
- 5. Protective boards: (Cementitious) (Wood fiberboard) (cladding per job specific)

3.0 EXECUTION

3.1 EXAMINATION

- A. Verify that substrate, adjacent materials, and plywood sheathing boards are dry and ready to receive insulation (and adhesive).
- B. Verify substrate surface is flat, free of ([honeycomb], (fins,) (irregularities,) (materials or substances that may impede adhesive bond).

3.2 RIGID BOARD PERIMETER INSULATION ABOVE-GRADE

- Follow Halo Exterra recommended installation instructions.
- B. Minimum vertical height: as detailed.







3.3 WORKMANSHIP

- A. Install insulation to maintain continuity of thermal protection to building elements and spaces.
- B. Keep insulation minimum (75 mm) (3 inches) from heat emitting devices such as recessed light fixtures, and minimum (50 mm) (2 inches) from (sidewalls of CAN4-S604 type A chimneys) (and) (CAN/CGA-B149.1 and CAN/CGA-B149.2 (type B) (and) (L) vents).
- C. Cut and trim insulation neatly to fit spaces. Butt joints tightly, offset vertical joints. Use only insulation boards free from chipped or broken edges. Use largest possible dimensions to reduce number of joints.
- D. Offset both vertical and horizontal joints in multiple layer applications.
