ROOF UNDERLAYMENT WARRANTY

Perma "R" Products Roofing Underlayment 20-Year Limited Warranty*

Use of the Perma "R" Products Roofing Underlayment products installed per the installation instructions; entitles you to certain quality assurance standards as provided in this Perma "R" Products Roofing Underlayment 20-Year Limited Warranty.

What Is Covered

Perma "R" Products ("PRP") warrants that Perma "R" roofing underlayment products (ProFelt Plus and ProFelt 30), originally installed after July 31, 2023, will have the ability to shed water and maintain structural integrity, for a period of twenty (20) years after the date of purchase of the Perma "R" roofing underlayment product, except as noted below.

This Warranty Does Not Cover Any Damages Arising From

(a) The negligence, gross negligence or willful misconduct of any third party; (b) Acts of God, including but not limited to, fire and lightning, hurricane, high winds; (c) Vandalism by any party; (d) Defects in the structure or a component of the structure (e.g., shingles, skylights or flashing materials) or selection of any components of the structure, or premature deterioration of the building materials; (e) Foreign objects or agents, including incompatibility of materials; (f) UV exposure of the Perma "R" roofing underlayment in excess of that set forth in the Physical Properties Data Sheet; or (g) Improper installation or the Perma "R" roofing underlayment, improper building practices or design not in accordance with the applicable building code or industry standards, or any deviation from approved construction plans or project specifications. The Perma "R" roof underlayment must be installed in accordance with the Perma "R" Building Products Installation Guide that is in effect at the time of installation of the Perma "R" roof underlayment. The installation guide is available by calling 1-800-647-6130 or visiting www.permarproducts.com.

How Long Coverage Lasts

This Warranty runs for twenty (20) years from the date on which the Perma "R" roofing underlayment was originally installed as a standard part of the roof system. If the Perma "R" roof underlayment is repaired or replaced, the Warranty will continue from the original date of installation and not from the date of repair or replacement.

Who can enforce this Warranty

This Warranty runs for twenty (20) years from the date on which the Perma "R" roof underlayment after July 31, 2023, on a construction covered by and meeting the terms of this Warranty can enforce this Warranty. This Warranty is transferable to subsequent owners within the Warranty's 20-year coverage period. Notwithstanding the foregoing language, PRP shall have no obligation under this Warranty unless and until PRP, the authorized applicator, and the material suppliers have all been paid in full for all materials, supplies, services, and other costs which are included in, or incidental to, the Perma "R" roof underlayment.

What PRP Will Do and What You Must Do

PRP will repair or replace the product or refund the purchase price for that portion of the product that has been proven to be defective. You will be responsible for any costs with or arising out of the repair or replacement or any correction. You must reasonably cooperate with PRP or its representatives in their efforts to fulfill their obligations under this Warranty.

How You Can Get Warranty Service

To obtain service under this Warranty, you must promptly contact PRP at **1-800-647-6130** regarding any potential claim, but no later than sixty (60) days after you discover any potential claim and provide PRP with proof of purchase and installation of the Perma "R" roof underlayment. You must provide PRP with a reasonable opportunity to inspect your home within sixty (60) days after PRP receives notice of your potential claim.

Exclusion of Damages

PRP's liability under this warranty is limited to the cost of the materials proven to be defective. PRP shall not be liable either in tort or in contract for any direct, incidental, consequential, or punitive damages, or lost profits, lost revenue, or loss of use, or any breach of any express or implied warranty.

Limitation of Implied Warranties

ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS LIMITED IN DURATION TO THE LENGTH OF THIS WARRANTY.

The foregoing is the only Warranty made by PRP for the Perma "R" roof underlayment. No representative, dealer, or other person is authorized to make or makes any warranty, representation or promise on behalf of PRP with respect to Perma "R" roof underlayment. No terms or conditions other than those stated herein or provided by law, and no agreement or understanding, oral or written, in any way purporting to modify this warranty shall be binding upon PRP unless made in writing and signed by and authorized employee of PRP. This Warranty gives you specific legal rights; other rights may also be available which may vary from state to state.
